#### Structure:

Rcc framed structure

Outer wall 8"/9" thick and internal partition wall of 4"/4 W thick walls.

#### Wall finishes:

Internal walls- Cement Plaster with interior paint with putty & emulsion paint for Hall, bed room & Rest of area cement paint. External walls - Cement plaster with exterior emulsion paint.

#### Floor finishes:

Living, Dining & Bedrooms - 2' x 2'Vitrified tiles.(ISI Brand) Balcony, Kitchen, Utility & toilets ceramic tiles(12"xl2").(ISI Brand)

#### **Doors and windows:**

Entrance Doors: Teakwood frames, with skin faced shutter (Varnish finish).

Bed room: Second quality Teak wood for Frames with Skin shutters with enamel paint finish.

Bath room: Teak frame with Waterproof door.

Windows: UPVC window and grills (10mm square rod).

#### **Toilets:**

Wall tiles up to 7 ft ht plain series.

Branded - Sanitary ware, wash basin, EWC (White color) (Parry ware). CP Fittings ISI brand.

Wall concealed ISI brand PVC pipe & Outer PVC pipe ISI brand.
